- Approximately 400 employees



- RCRA CORRECTIVE ACTION/CERCLA REMOVAL ACTIO
- GM CETC BEDFORD FACILITY, BEDFORD, INDIANA
- Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) Removal Action (RA)
  - Bailey's Branch and Pleasant Run PCB cleanup of creek sediments and floodplain soil.
  - RA Elements:
    - Control of impacted springs and seeps along creeks; and
    - Removal of floodplain soil to 1.8 ppm and sediment to 1 ppm in the creek.
  - GM is consolidating remaining creek soil removal work with East Plant capping as part of an agreement previously reached with RACER Trust (formerly MLC).
    - Balance of soil removal will be completed this year.
  - Remedy for large spring on Baileys Branch to be implemented this year.
  - Restoration will continue into 2012.








# SPRING 018

RCRA CORRECTIVE ACTION/CERCLA REMOVAL ACTION

GM CETC BEDFORD FACILITY, BEDFORD, INDIANA

- Construct French-drain east of Spring 018
- Clean groundwater collected in the French-drain will be diverted around Spring 018 and discharge into the creek downstream of the Spring
- After rerouting of clean water, the reduced volume of water discharged at Spring 018 will continue to be collected and treated at one of the on-Site water treatment plants
- Currently in design phase, construction scheduled for 2011






# TRUCK TRAFFIC ROUTES

### RCRA CORRECTIVE ACTION/CERCLA REMOVAL ACTION

- Road traffic has resumed with the resumption of removal work at Area G.
- CRA monitors safety of truckers.
- GM will continue to monitor the need for patching roads once project truck traffic resumes in 2011.
- Once project truck traffic has ended, GM will place a final surface layer on the portions of Peerless and Breckenridge Roads paved in early 2010.

GM CETC BEDFORD FACILITY, BEDFORD, INDIANA

- RCRA Corrective Action
  - Conducted in accordance with a performance-based agreement with the U.S. EPA Region V. The agreement was signed on March 20, 2001 and amended October 1, 2002, March 29, 2008, and May 9, 2008.
  - Groundwater testing completed March, April and June 2011.
  - Next testing to be completed in September/October
  - Bedrock studies were completed at AOI 8 this spring to facilitate the collection system design.
  - Implementing Interim Measures:
    - East Plant Area
    - West Plant Area
    - Commercial properties west of the Facility

- Cover construction will be completed in 2011.

- Packer testing on existing NAPL wells as part of additional bedrock studies at AOI 8
- Vertical NAPL delineation testing at 2 wells southeast of the facility started in March 2011
- NAPL Recovery tests
- Design of NAPL recovery system following review of collected data in 2011
- Construct recovery system in 2011/2012



  - A Work Plan was developed for periodic removal of oil from CH-5 discussing:
    - Recording recovery and recharge rates
    - Water level monitoring to determine potential influences from CH-5 recovery efforts
  - Recovery test will be conducted in 2011
