#### 1.0 <u>INTRODUCTION</u>

This Quarterly Progress Report is submitted in accordance with the Bedford Voluntary Corrective Action Agreement (Agreement) between the U.S. EPA and GM, executed on March 20, 2001. This report covers the period from execution of the Agreement on March 20, 2001 to the end of the second calendar quarter of 2001 for the GM-Powertrain – Bedford Plant (Facility).

The next quarterly progress report will be submitted on or before October 15, 2001.

#### 2.0 <u>LIST OF COMPLETED ACTIVITIES</u>

Each of the submissions identified in the Agreement has been submitted on or before its due date. The following is a list of those submissions, their due date, and the date that they were submitted to the U.S. EPA.

A project initiation meeting was held at the GM Powertrain Bedford Plant involving representatives from GM, U.S. EPA, and IDEM on June 6, 2001, to discuss the overall RCRA Corrective Action Program, RFI strategy, schedules, and the above referenced documents. The above referenced meeting was followed with a conference call between GM, U.S. EPA, and IDEM representatives on June 20, 2001, to further discuss project activities and the future project schedule.

The Project Fact Sheet #1 has been issued, and the Bedford Public Library has been contacted regarding setting up a public information repository.

## 6.0 <u>CHANGES IN PERSONNEL DURING THE REPORTING PERIOD</u>

A summary of personnel was included in the CRP submitted June 6, 2001. Any changes in personnel during the next reporting period will be presented in the next Quarterly Progress Report.

## 7.0 PROJECTED WORK FOR THE NEXT REPORTING PERIOD

The Quality Assurance Project Plan (QAPP), Health and Safety Plan (HASP), and RFI Sampling Matrix are scheduled to be submitted to the U.S. EPA in mid-July 2001, with copies also sent to IDEM. The off-site well survey and sampling activities are scheduled to begin on approximately July 23, 2001. The Stream Investigation Work Plan is

projected to begin on approximately August 13, 2001. Additional site investigation activities from the RFI Work Plan will commence following submission of the overall RFI Work Plan in late July 2001 after review of U.S. EPA's comments.
